MIKE CRAPO RAKED IN MONEY FROM PACS AND FINANCIAL SERVICES INDUSTRY AS HE WAS POISED TO BECOME SENATE FINANCE CHAIRMAN

SUMMARY: Between the 2020 general election and the January 2021 Georgia Senate runoff elections, Mike Crapo was slated to become the next Senate Finance Committee chairman. As chairman, Crapo would run the "most powerful" committee in the Senate that has jurisdiction over issues like taxation, trade, and government-funded healthcare programs.

From October to December 2020, Crapo received over \$40,000 in contributions from the pharmaceutical/insurance and financial services industries:

- Crapo received \$19,800 in contributions from pharmaceutical and insurance industries, of which \$14,500 came after election day, including \$9,500 on Nov. 6th.
 - At least one pharmaceutical group that contributed to Crapo has engaged on Senate Finance Committee matters since the beginning of 2021.
- Crapo also received \$25,500 in contributions from the financial sector, of which \$11,500 came after election day, including \$10,500 on Nov. 6th.

Additionally, Crapo received \$21,250 in PAC contributions from November 6-7th 2020—including that same pharmaceutical group that has engaged on Senate Finance Committee matters in 2021. From October to December 2020, Crapo received over \$196,000 in PAC contributions, far surpassing that of:

- Crapo's PAC contributions from the previous three quarters of 2020, which totaled \$112,490.
- Crapo's own campaign, from the most recent comparable period, October to December 2018, during which he received just \$16,000 from PACs.
- Idaho Senator Jim Risch, who was actually up for reelection in 2020, received \$137,800 in contributions from PACs during the 4th quarter of 2020.
- Former Finance Chairman and current Judiciary Ranking Member Chuck Grassley, who received \$47,575 in contributions from PACs during the 4th guarter of 2020.

After The November 2020 Election, Senator Mike Crapo Seemed "Poised To Take The Chairmanship" Of The Senate Finance Committee. "Idaho's senior senator appears poised to take the chairmanship of one of the U.S. Senate's most powerful committees. Sen. Chuck Grassley, R-lowa, is expected to give up his current chairmanship of the Senate Finance Committee and return to running Senate Judiciary next year, Politico reported last week. U.S. Sen. Crapo has been on the committee for the past few congresses, and currently serves on its subcommittees on Health Care; Energy, Natural Resources and Infrastructure; and International Trade, Customs and Global Competitiveness. "The report found that Novo Nordisk and Sanofi — two of the largest insulin makers in the U.S. — would closely monitor the other's prices and match or top any price increases, sometimes within hours or days of each other. 'Rather than seeking to undercut its competitors' pricing, from 2014 on Novo Nordisk engaged in a cat-and-mouse strategy of pricing that followed Sanofi's price increases closely, sometimes mirroring them within days or even hours,' the report reads."
