# Corporations That Claim To Support The John Lewis Voting Rights Advancement Act Have Donated Over \$164,000 In 2021 To Republican Senators Who Blocked The Bill

**SUMMARY:** The John Lewis Voting Rights Advancement Act would have restored provisions of the Voting Rights Act and <u>strengthened protections</u> against discriminatory state laws. Senate Republicans, however, refused to support the bill and <u>blocked</u> debate on the legislation.

Since July 2021, hundreds of businesses have signed on to a <u>letter</u> in support of restoring the Voting Rights Act. Yet, so far in 2021, major corporate signers of the letter have donated at least **\$164,500** to the Senate Republicans that blocked the bill the companies claim to support. These corporations include:

- **Microsoft Corporation** signed on to the letter, but donated a total of **\$15,500** to Senate Republicans.
- Amazon signed on to the letter, but donated a total of \$22,500 to Senate Republicans
- Facebook signed on to the letter, but donated a total of \$26,500 to Senate Republicans.
- Intel Corporation signed on to the letter, but donated a total of \$7,500 to Senate Republicans.
- Cisco signed on to the letter, but donated a total of \$5,000 to Senate Republicans.
- Target signed on to the letter, but donated a total of \$32,000 to Senate Republicans.
- **Dell Technologies** signed on to the letter, but donated a total of \$38,500 to Senate Republicans.
- Boston Scientific signed on to the letter, but donated a total of \$17,000 to Senate Republicans.

The Voting Rights Act Of 1965 Outlawed Discriminatory Voting Practices And Has Been Reauthorized Multiple Times In The Decades Since Its Original Passage With Bipartisan Support.

The Voting Rights Act Became Law In 1965 To Outlaw Discriminatory Voting Practices That Mainly Targeted Black Voters, Including Bureaucratic Restrictions Meant To Deny Them The Right To Vote.

The Voting Rights Act Was Created In Response To Decades Of Black People Facing "Tremendous Obstacles To Voting, Including Poll Taxes, Literacy Tests, And Other Bureaucratic Restrictions To Deny Them The Right To Vote." "This 'act to enforce the fifteenth amendment to the Constitution' was signed into law 95 years after the amendment was ratified. In those years, African Americans in the South faced tremendous obstacles to voting, including poll taxes, literacy tests, and other bureaucratic restrictions to deny

them the right to vote. They also risked harassment, intimidation, economic reprisals, and physical violence when they tried to register or vote. # The Voting Rights Act Of 1965 Has Been Reauthorized Multiple Times By Congress With Bipartisan Support, Including Bills In 1982 And 2006, Which Were Both Backed By Current Republican Senators.

In 1982, Congress Reauthorized The Voting Rights Act Of 1965 And Extended Its Preclearance Requirements. "(Measure passed Senate, amended, roll call #190 (85-8) (Inserted text of S. 1992, as amended)) Amends the Voting Rights Act of 1965 to extend from August 6, 1982, to August 6, 1984, the current preclearance requirements (under which jurisdictions covered through the triggering mechanism must submit proposed electoral changes to the Department of Justice).
