SUMMARY: Throughout the fourth quarter of 2021, major corporations donated at least \$320,500 to Minority Leader Kevin McCarthy. Leader McCarthy is not only subject to a <u>request for information</u> by the committee investigating the insurrection, but is also facing a <u>potential subpoena</u> due to his <u>refusal</u> to cooperate with the investigation. These corporations include:

- UnitedHealth Group donated \$10,000 to the McCarthy Victory Fund.
- **Wells Fargo** contributed **\$5,000** to McCarthy's campaign committee.
- Comcast donated \$5,000 to McCarthy's campaign committee.
- Ford gave \$5,000 to the McCarthy Victory Fund.
- Eli Lilly contributed \$5,000 to the McCarthy Victory Fund.
- American Airlines donated \$5,000 to the McCarthy Victory Fund.
- Pfizer gave \$2,500 to the McCarthy Victory Fund.
- Raytheon Technologies contributed \$2,500 to McCarthy's campaign committee.
- Boston Scientistic Corporation gave \$2,500 to McCarthy's campaign committee.
- Duke Energy donated \$2,500 to the McCarthy Victory Fund.
